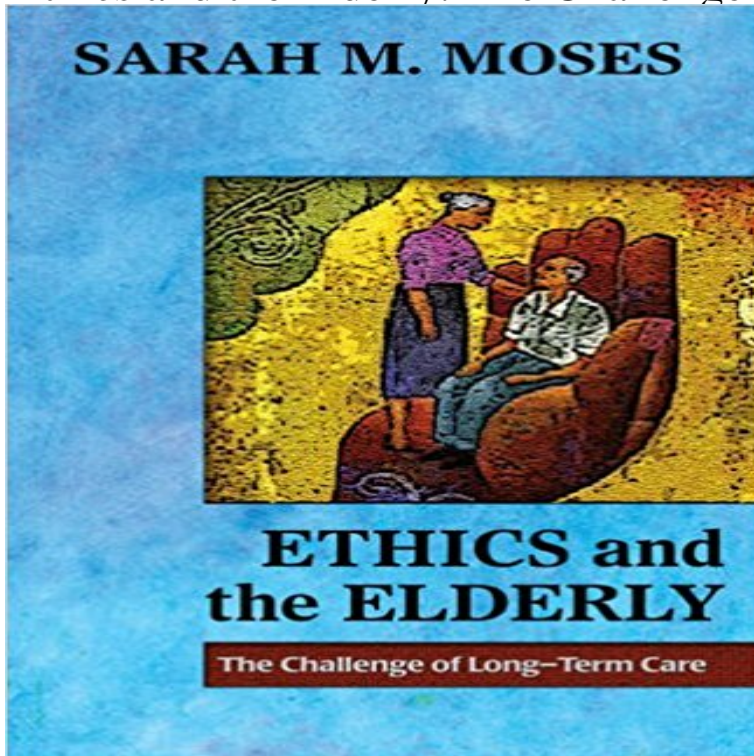


# Ethics and the Elderly: The Challenge of Long-Term Care
