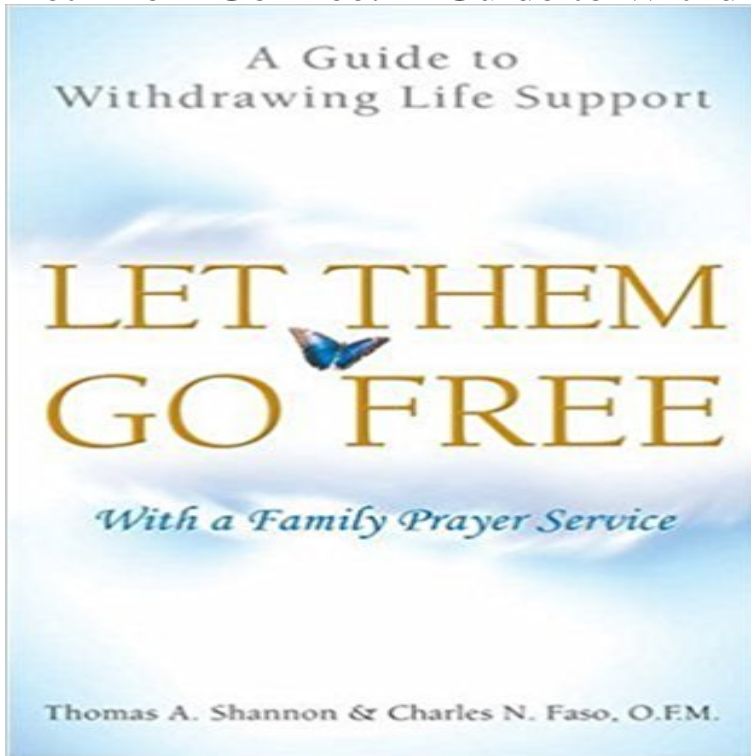


Let Them Go Free: A Guide to Withdrawing Life Support
